Boarding Contract

Liability Release

I, _____ release all liability from Brentwood Pet Resort Inc. located in Brentwood, CA 94513. In case of injury, accident or illness, I do understand that Brentwood Pet Resort Inc. will take the very best care of my pet(s) and every precaution for the health and welfare of my pet(s).

This is a contract between Brentwood Pet Resort Inc. and the pet owner/client whose signature appears below (hereinafter called "owner").

1. Owner agrees to pay the rate for boarding in effect on the date pet is checked into the kennel (as posted in office).
2. Owner further agrees to pay all costs and charges for special services requested and all necessary costs for the pet(s) during the time said pet is in the care of kennel.
3. Owner further agrees that the pet shall not leave kennel until all charges are paid to the kennel.
4. By signing this contract and leaving their pet(s) with the kennel, Owner certifies to the accuracy of all information given about said pet(s).
5. Kennel shall exercise reasonable care for the pet(s) delivered by the Owner to the kennel for boarding. It is expressly agreed by Owner and kennel that kennel's liability shall in no event exceed the lesser of the current chattel value of a pet if the same species or the sum species or the sum of \$200.00 per animal boarded. The Owner further agrees to be solely responsible for any and all acts of behavior of said pet while it is in the care of the kennel.
6. Owner specifically represents that he or she is the sole owner of the pet(s), free and clear of all liens and encumbrances.
7. Owner specially represents to kennel that the pet(s) have not been exposed to rabies or distemper within a 30-day period prior to boarding.
8. All charges incurred by Owner shall be payable upon pick up of pet(s), or when billed by kennel at address listed on contract. The kennel shall have and is hereby granted a lien on the pet(s) for any and all unpaid charges resulting from boarding pet(s) at the kennel. Kennel may dispose of pet for any and all unpaid charges, at private or public sale, at the sole discretion of the kennel, and Owner specifically waves all statutory or legal rights to the contrary. If such sale shall not secure a price adequate to pay such cost of board and other charges delinquent, plus cost of sale, the Owner shall be liable to kennel for the difference. All monies received by kennel at such sale, over and above the charges due and cost of sale, shall be paid kennel to owner.
9. If a pet becomes ill or if the state of animal's health otherwise requires professional attention the kennel in its sole discretion may engage the services of a veterinarian or administer medicine or give other requisite attention to the animals and the expense thereof shall be paid by the Owner.
10. This contract contains the entire agreement between the parties. All terms and conditions of this Contract shall be binding on the heirs, administrators, personal representatives and assigns of the Owner and the kennel.
11. Any controversy or claim arising out of or relating to this contract, or the breach thereof, or as the result of any claim or controversy involving the alleged negligence by any party to this contract, shall be arbitration in accordance with the rules of the American Arbitration Association, and judgment upon the award rendered by an arbitrator may be entered in a Court having jurisdiction hereof. The arbitrator shall, as part of his award, determine an award to the prevailing party of the costs of such arbitration and reasonable attorney's fees of the prevailing party.

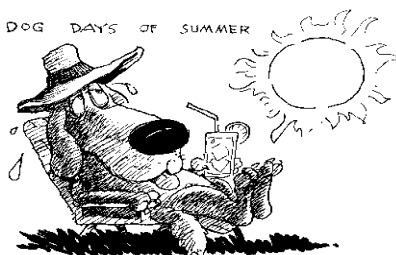
